

# **Aptis ESOL**

## Parental consent form

Test takers should be 18 years old on the registration date in order to be able to book the test themselves online. If a test taker is less than 18 years old on the registration date but 18 years old on the test date, they should contact the test centre directly to book Aptis ESOL test.

If a test taker is under 18 on the test date and still wishes to take Aptis ESOL, this consent needs to be signed by a parent/guardian.

#### Please read this information carefully before you complete and sign this consent form.

This form provides the British Council with information about who will be collecting the child after the test or provides confirmation that the child is permitted to leave exam premises unaccompanied.

Your completed consent form must be either provided prior to the test or taken to the exam day and given to the exam supervisor. If you do not provide this consent form, your child will not be allowed to sit Aptis ESOL. We recommend that you keep a copy of this form for your records.

#### **Child Safe Collection Policy**

A child is defined as any person who has not reached their 18th birthday. The British Council believes that the care, protection and welfare of children are paramount and that all children have the right to be protected from harm. This includes our commitment to effective child protection systems and ensuring children are safely collected from exam premises.

Any subsequent change to the person who comes to collect the child must be authorised in writing by the parent/carer.
